Foster agrees to feed, water, and otherwise care for the animal/s, to monitor the health of the animal/s, including transport to an approved veterinarian when necessary, and to administer any necessary veterinary medicines *	YES

Foster agrees to provide photos of the dog/s and a regular status reports via e-mail/text correspondence to tel number and email supplied by APN. Such status reports will aid significantly in the placement of the animal/s into a permanent home by Animal Protection Network and other volunteers. Basic information about the animal/s health and personality should be provided. However, Foster agrees to contact Animal Protection Network immediately in the event of any medical emergency, loss or theft of the animal/s, or any signs of aggression (growl, snap, snarl or bite) toward any human or other animal. Foster agrees that upon approval of an application for fostering by Animal Protection Network, Foster will discuss the animal/s with any approved applicant. Foster is encouraged, but not required to assist Animal Protection Network in finding a good match *	YES	

Period of Fostering		
Foster agrees to foster the animal/s until a suitable permanent home can be found or until Animal Protection Network can make alternative foster arrangements. Foster understands that Animal Protection Network has high standards for permanent homes and that the fostering period could range from one week to several months. Animal Protection Network agrees to make a good-faith effort to find a suitable match as quickly as possible. *	YES	
Veterinary Care		
Animal Protection Network agrees to provide the animal/s all necessary veterinary care through its approved veterinarians at its sole expense after approval. Foster agrees to contact Animal Protection Network for approval prior to obtaining any veterinary care for the animal/s. Animal Protection Network has the right to deny reimbursement for unapproved veterinarian expenses. All fosters should ensure that their personal dogs/cats are up-to-date with their current vaccinations. Animal Protection Network is not responsible for any veterinary bills for resident pets.	YES

Should an emergency arise, Foster agrees to obtain medical care for the animal/s after contacting Animal Protection Network for approval. Animal Protection Network shall reimburse the Foster for justified emergent care that is pre-approved. Foster agrees to make good-faith effort to obtain such care from an approved veterinarian if possible.	YES	
Rights of Ownership		
Animal Protection Network retains all property rights and/or ownership over the animal/s. Animal Protection Network may retake possession of the animal/s at any time or for any reason	YES	
Waiver of Liability		
Upon Animal Protection Network's physical transfer of the animal/s to Foster, Foster personally and voluntarily assumes all risks in connection with fostering the animal/s. Foster hereby releases and forever discharges Animal Protection Network and its representatives from any and all loss, liability, actions, causes of actions, suits, claims, demands, damages or causes of any kind or nature whatsoever, which arise out of or are based upon any fact, matter, injury, damage, or claim arising out of this Agreement, the fostering addressed in it, or the animal/s. The Foster acknowledges that dogs are unpredictable and agrees to take all necessary precautions for the safety of the Foster, their family members and household, and the animal/s.	YES	

Additional Information:

- 1. * If you rent, a copy of your lease and addendum for pets must be presented to Animal Protection Network.
- 2. * By signing this fostering application, <u>you agree to provide vaccinations</u>, <u>health check-ups and any additional veterinary care</u>, by a qualified veterinarian, on a yearly or as-needed basis.
- 3. * By signing this fostering application, <u>you agree to have this pet spayed or neutered</u> if he/she is not already sterilized. A deposit may be required for non-sterilized animals, which will be returned to you upon receipt of a signed letter from your veterinarian indicating date of spay/neuter surgery.
- 4. *Your fostering fee is a donation to Animal Protection Network which covers all costs incurred by Animal Protection Network during the rescue of this animal, and is <u>non-refundable</u>. Should you wish to make a donation over and above the fostering fee to support our work we would be most grateful.
- 5. Please note that you cannot pass this foster animal onto another person, if you are no longer able to care for it, without the specific permission of Animal Protection Network. The Home Check process will be done for the new home before approval is granted.
- 6. By signing this form, I/we acknowledge that the information on this form is true and correct.

- 7. I/we agree to all provisions indicated on this form. I/we understand that any misrepresentation of fact may result in Animal Protection Network refusing fostering privileges to me/us. If my/our request for fostering is approved and later Animal Protection Network discovers the above information is not true or correct, this application becomes null and void, and because of my breach of contract, Animal Protection Network reserves the right to remove the fostered pet from my home, and I will be held responsible for any associated legal costs incurred as part of said reclamation process.
- 8. In order to ensure the best homes for our rescued pets, we reserve the right to deny any foster application.
